# How to Become a Member

- Physician must have hospital privileges at either Providence hospital before applying to join the PMG
  - Request application by contacting Nancy Henning at nancy.henning2@ascension.org
  - Application and contracts will be emailed to applying physician
- When the application and contracts are returned to the PMG, the physician's request for PMG membership is taken to the PMG Credentials Committee and PMG Board for approval.
- •If the physician's application for membership in the PMG is approved by the PMG Board, the physician becomes a member. PMG administrative staff then notifies St. John Providence Partners in Care to arrange for the physician's participation in the various health care plans.
